INFORMATION NOTICE as per Articles 13 and 14 of Regulation 2016/679 EU (personal data protection)

Processing purposes

The purpose of the processing of your personal data is to allow the supply of the diet requested and the surveillance activities by the Comunità di Valle (Valley Community) and by the firm managing the cafeteria service. The data shall be processed using manual, IT and telematic instruments with organization and processing logic closely pertinent to the purpose stated, and in such a way as to guarantee the security, integrity and confidentiality of said data via adequate technical and organizational measures.

Data conferment and processing: Data conferment is mandatory in order to provide the alternate diet. This is to inform you that, for the performance of this service, also 'special' data as described in Art. 9 of Regulation 2016/679 EU will be acquired and, therefore, we hereby ask you for your explicit consent to their processing. Your refusal to confer the personal data and to give your consent shall prevent us from supplying the alternate diet. Please be advised that any changes to the data that may arise after their conferment must be promptly notified to the Data Processor for their correction/addition.

Data recipients: The data collected shall be communicated to and processed by the employees and agents of the Data Controller and of the Data Processor who are duly authorised to do so and under the obligation of confidentiality. The data may also be communicated by subjects appointed by the APSS or by other public bodies and agencies if such transfer is envisaged by law or by regulations. The data supplied shall never be released, **diffused** or communicated to other third parties, except for the subjects who are entitled to access these data by law or by order of the competent authorities.

Data storage period

The data shall be stored for the time necessary for executing the request (indicatively, for the school cycle intended) and subsequently for another 30 days, after which they will be erased.

Rights of the data subject: At any time you may exercise the following rights: a) Revoke the previously given consent. b) Oppose the processing of your data, when it occurs on a juridical basis other than the giving of consent. c) Obtain information regarding the data processed by the Data Controller regarding specific aspects of processing, as well as receive a copy of the data processed. d) check the correctness of your data and request their updating or correction. e) Under certain conditions, request the limitation of the processing of one's personal data (in which case the Data Controller shall not process the data for any other reason than their storage). f) Under certain conditions, request that the Data Controller erase the personal data. g) Where technically feasible, receive one's personal data in a structured, commonly used and machine-legible format and obtain their transfer to another Data Controller.

In the event of lack of or only partial response, the data subject may lodge a complaint with the Supervisory Authority by following the procedure indicated on the website www.garanteprivacy.it. You may exercise your rights by sending a written request on paper or by e-mail to the Data Processor's contacts indicated above.
